Letter from Dave Fauth, SRSRA Chair

Merry Christmas and Happy New Year SRS Family,

I hope you find 2021 more accommodating than last year. We are preparing for the annual meeting at USC-Aiken but realize that April is too soon to have a worthwhile meeting and we have moved the event to late September.

I want to start by saying how proud I am of the Resource Center staff, Laureen Feinman, Jeanne Szymanski, and our SRSRA volunteers! We conducted another highly successful Medicare Prescription Drug Plan Review and Enrollment helping about 650 retirees/spouses despite the roadblocks created by COVID-19.

I am happy to announce that we have opened association membership to SRS non-retiree spouses at no cost if their significant other is a current member. When renewing your membership simply include the name of the spouse on your application. We may already have their name if they have used the services of the Resource Center.

Unfortunately, our Resource Center has not been fully available to us since mid-March and as we begin 2021, this remains the situation. Right now, we are limited to one day a week and only our RC manager may enter the building due to social distancing COVID restrictions. We are utilizing our volunteers to assist you from their homes. We may sometimes be slow to respond to phone messages but we will continue to respond to your requests as soon as we can. Please remember to answer your telephone calls if you have left us a message. The volunteers will be returning your calls from their homes so you may not recognize the numbers.

In 2021, we will again be offering our monthly Aging into Medicare meetings on Tuesday and quarterly on certain Fridays. We thank the City of Aiken for allowing us to use the large classroom at the Aiken Municipal Building, 214 Park Avenue in Aiken for the first quarter of 2021. Class curriculum is designed to help retirees/spouses make the best possible Medicare decisions tailored to their needs.

We have also been utilizing our Facebook page to keep everyone current on our SRSRA activities and information of value to our membership. We now have 942 members in our Facebook group. This site is an inexpensive means to keep us all up-to-date on information that affects us and our families. Ask your family members or close friends to keep you abreast on our social media news. Let us know what information you would like to see. New important and critical information about COVID-19 vaccine access has been posted there.

Benefits Protection Committee

Recently the Site sent each retiree a letter that informed us that Transamerica was becoming the new service provider for the Savannah River Nuclear Solutions, LLC Multiple Employer Pension Plan (MEPP). Because of this change, each retiree is encouraged to set up an on-line account to view your pension benefits and for your Savings and Investment Plan (SIP), if you still have money in this program. If you have already set up a Transamerica account for your SIP, you do not need to set up another account for your pension – both show up on the same account.

To create an on-line account at Transamerica

- 1. Visit transamerica.com/portal/srsretire
- 2. Click "CREATE AN ACCOUNT" in the top-right corner
- 3. Follow the prompts to set-up your on-line account

Once you have completed the on-line set-up process, select your MEPP (pension) account. You will then be on the "Your Information" page. This is where your address of record is shown, along with the benefit you are currently receiving from the MEPP (pension) plan and the beneficiary you have designated for this benefit. Not all information may show up on the Transamerica database at this time, because some of the information (pre-2012), such as beneficiaries chosen when people first retired, are in off-Site storage locations, and it is taking time to pull that information out to be added to the Transamerica database.

The SRSRA encourages all retirees to set up this account, since it may be required in the future, and to check the information that is in the system. It is especially important to check the beneficiary designation.



Retiree Resource Center Report

COVID times settled over the Retiree Resource Center with its ominous presence taking away the precious face-to-face services both the retirees and volunteers had come to value so much. First, no more retiree clients were allowed in the building. Then, our volunteers were allowed to come in only occasionally on unpredictable schedules. Next, our Age-In-Training meetings, so important to our new retirees, were no longer allowed. Finally, as our crucial Medicare Open Enrollment period began in October 2020, the wonderful data systems Ranny Saylor had developed were no longer accessible because we now work from home.

But these difficulties brought out the very best efforts from our volunteers. They did not let themselves be discouraged, despite the glitches with the government's <u>MyMedicare</u> plan comparison and enrollment website, a number of retirees who requested Rx reviews but did not answer the phone when volunteers tried to call them back, and the myriad of new procedures which had to be set up. All this meant the Medicare Rx reviews for 2021 took roughly three times as long for the volunteers to do remotely compared with doing them in person. **But the volunteers overcame all the problems and reviewed our largest number of plans during a Medicare Open Enrollment season in six years!**



We are still imputing the data from the Rx home reviews into our database, but a preliminary assessment shows over 75% of the plans reviewed for the 2021 plan year needed a change away from their current insurance carrier or pharmacy to obtain the most competitive total out-of-pocket costs based on the retirees' specific drugs. Annual Rx reviews for retirees are a necessity.

"Benefitting You"

• Are you eligible for payment under the Catastrophic Drug Benefit for the 2020 plan year? <u>Your claim must be postmarked by February 28th</u>.

You must submit (1) a copy of the Right Opt Catastrophic Drug Plan Application for Plan Year 2020 and (2) Your final Prescription Drug Plan (or Medicare Advantage Plan) EOB (Explanation of Benefits) for December 2020 showing the amount of out-of-pocket expenses for the year while in Stage Four Catastrophic Coverage. This is generally when you have more than \$6,350 in covered out-of-pocket prescription drug costs. Call Right Opt at 877-591-8904 or the Retiree Resource Center at 803-508-7065 and we'll help you check your eligibility and file your claim.

- What happened to my Liberty Mutual Home and Auto Insurance I have been purchasing through SRS? SRS has discontinued its relationship with Liberty Mutual as of December 31, 2020. All existing policies will remain in force with current plan features and rates through the existing term of the policy. Call Liberty Mutual to arrange future payments and for general questions at 1-800-295-2820.
