SRSRA Membership



Anyone who has been employed at or in direct association with the Savannah River Site for at least five years and who has since retired from that employment and their spouses are eligible. All spouses of retiree members, whether SRS retirees themselves or not, are eligible for membership in the SRSRA.

Annual dues for the Association are \$25. For surviving spouses of retirees, annual dues are \$5. Dues may be paid up to 3 years (current plus 2 future years). To join, go to fill out the membership form at https://www.srsretirees.org/membership/.

Our Volunteers Keep on Working! Special Appreciation to Ken Perrine, PhD



Ken filed the largest single retiree SRS stipend claim on record! The claim was for \$57,088. This money really helped this family with private care nursing expenses for the retiree.

Several of us contacted this retiree and his family over three years urging them to file for their retired dad's benefit. Their father is now living outside the CSRA and has been receiving private nursing care for a number of years. It was Ken who was finally successful working with them and compiling the documentation, and Ken who filed the claim on their behalf. They were all very grateful.

Ken has been volunteering his time to the SRSRA Retiree Resource Center for the past eight years, handling over 258 office and home visits, assisting retirees ready for Medicare and the SRS HRA stipend process, helping with the annual Rx Review process, and counseling retirees about the best approaches to access and claim their SRS stipend allocations. He's been a great volunteer.

Ken is also a strong community volunteer working with Hitchcock Woods, his church, and other organizations. The new edition of his beautiful guide, *Trailside Flora of the Hitchcock Woods*, is available in hard copy or online, and he also recently developed an app that can be accessed on Android® cellphones so you can identify the flowers as you hike. Ken is an example of someone who
