About the SRS Retiree Association (SRSRA)

The Association was founded in 1998, this is our 26th year of supporting SRS retirees. The 2024 membership total was 1,999 members, an all-time high. We have members in 28 states and 218 cities, most members (91.9%) are from Georgia or South Carolina, 54.7% from Aiken County with 35.2% from Aiken. Membership (\$25 annually) is available to anyone retired under the previous Westinghouse Savannah River Company – Bechtel Savannah River Incorporated retirement plan or in the successor plan, currently called the Savannah River Nuclear Solutions, LLC Multiple Employer Pension Plan. This includes retirees from WSRC, BSRI, WSMS, BNFL, URS, SRNS, SRR, SRMC and BSRA.

Annual dues are from January 1 through December 31 and can be paid anytime. Dues can be paid for up to three years – current year plus the next two. Retiree membership is \$25 and Surviving Spouse \$5. All members' spouses (SRS retiree or not) can join for \$0.

The easiest way to pay dues is online. Go to our website – srsretirees.org – there is a Join or Renew Membership button near the bottom of the page. It lets you complete an electronic form and takes you to our PayPal account to make a payment. If you do not have a PayPal account, there is a paper copy form there you can complete and mail to us, if that is your preferred method.

We need volunteers to serve on the Board and/or perform services at the Resource Center to continue operations through our 27th year. Please encourage all retirees to join the Association, especially those that use the Resource Center services.

Contacting Congressional Representatives

The SRSRA encourages all retirees to express their retiree related concerns to their congressional representatives. The first step in communicating with your legislators is to find out which elected officials are yours.

You can identify your Senators and find their specific office address on the Senate website at https://www.senate.gov/senators/senators-contact.htm. Similarly, you can identify your U.S. Representatives by your address and zip code and get their specific office address on the House web page at https://www.house.gov/representatives/find-your-representative.

When you draft your letter to your elected official, be sure to include your phone number and your address (email, if you have one). Depending on your issue, you may be contacted by a member of the official's staff for more information on the topic.

It is important to explain why you are contacting them. For SRS retirees a reason for contacting could be as simple as "...a cost-of-living-adjustment (COLA) for the pensioners of the contractors for the Department of Energy at the Savannah River Site in Aiken, SC." or, an increase in the benefits stipend.

When you write, be sure to ask what your representatives plan to do about your issue. As you write consider including a reference to the SRSRA as it may help us help you and the SRSRA in future discussions with the elected official, the DOE, and the contractors responsible for our benefits. You might consider sending a copy to the SRSRA (address on the front page).

SRSRA Retiree Resource Center

The Resource Center is sponsored and managed by the Association's Board. The primary funding source is from members' dues payments and donations. Assistance is provided to retirees transitioning into Medicare, Medicare issues, Open Enrollment, stipend reimbursements, etc. The Resource Center has two part-time employees but most of the support is provided by retirees who volunteer their time. This year the Resource Center assisted 940 retirees/spouses with only 48.0% supporting this effort by paying membership dues. We encourage all retirees to join the Association, especially those that use the Resource Center services. The easiest way is join online. Go to the website – srsretirees.org – there is a Membership Button near the bottom of the page.

Additional volunteers are urgently needed to continue the support provided by the Resource Center. Please volunteer now so you can train with experienced personnel.

Important items for SRS retirees:

1. **If you changed plans during open enrollment**, make it a priority to verify that your new Medicare Supplement Insurance and Medicare Rx Drug Insurance, or your Medicare Advantage Plan Insurance policy, is actively in force as of January 1, 2025. Proof of 2025 coverage may be in the form of a 1) letter from the new insurance carrier or broker, 20 new plan membership card, 2) confirmation of coverage email with your new membership number, or 3) website detailed verification through VIA or the insurance carrier.

Why should this be a priority? SRMC offered a Humana <u>Guaranteed Issue</u> Medicare Supplement Plan for their retirees if they enrolled through VIA for 2025. Some retirees have not received confirmation of that coverage even though they submitted their application for this one-time offer for a Humana Medicare Supplement Plan with no medical underwriting required. If you made this change and have not received a confirmation of your new coverage showing an effective date of January 1, 2025, and showing the Plan type you applied for (such as Plan F, Plan G etc.), or if you have received an application denial from Humana, or if you received a confirmation for a High Deductible Medicare Supplement Plan when you applied for a regular Medicare Supplement Plan, you need to take action immediately. The SRMC VIA website does not have all the new 2025 enrollment information posted for everyone yet, which is why you should make it a priority to check your confirmation letters and emails. SRMC is aware and focused on this problem. If you have experienced any issue or have not received evidence of your new 2025 insurance coverage, please contact SRMC Stephen Barry at 803-645-0845. You can also contact Mr. Barry by email, stephen.barry@srs.gov. A call would be more expedient.

- 2. Are you paying close attention to your **prescription drug expenses** now that the Medicare Catastrophic Limit has decreased to \$2,000 annually? Some retirees choose to use drug discount cards like Good Rx, or store plans like Kroger's, to control their costs of certain medications. Now that the Medicare Catastrophic Limit has decreased to \$2,000, it will often be less expensive to purchase your medications through your Rx or Medicare Advantage prescription drug plan if you have high drug expenses since your annual total will be over the threshold sooner.
- 3. Please be on the lookout for information from Transamerica regarding a limited opportunity under the Savannah River Nuclear Solutions, LLC Multiple Employer Pension Plan and Trust (the "Pension Plan"). This election applies to certain groups of retired SRS employees who vested in the pension plan and terminated their employment before retirement age. For more information, call Transamerica at 888-976-8196.
- 4. Did you receive your **SRNS** or **SRMC** stipend allocation in January? Are your claims set up to automatically reimburse your checking account which is the fastest and least complicated process? If you need help, you can call HealthEquity at 877-924-3967 (SRNS) or VIA at 800-848-1831 (SRMC), or our SRSRA Retiree Resource Center message line at 803-226-0070 and you'll be helped you with your questions.
