## SRS Retiree Association (SRSRA) Membership

Please continue to support the SRS Retiree Association and what the Resource Center does in assisting retirees transitioning into Medicare, Medicare issues, Open Enrollment, stipend reimbursements, etc. The Resource Center is sponsored and managed by the Association's Board. The primary funding sources for the SRSRA are members' dues and donations. Most of the Resource Center staffing is provided by retirees who volunteer their time.

Membership is available to anyone retired under the previous WSRC – BSRI retirement plan or in the successor plan, currently called the SRNS, LLC Multiple Employer Pension Plan. This includes retirees from WSRC, BSRI, WSMS, BNFL, URS, SRNS, SRR, SRMC and BSRA. Annual dues ensure membership for the calendar year, January 1 through December 31, and can be paid anytime. Dues can be paid for up to three years—current year plus the next two. Retiree membership is \$25 and surviving spouse is \$5. All member spouses (SRS retiree or not) can join for \$0.

An easy way to pay dues is through the webpage. Go to the website, srsretirees.org. Click the "Join or Renew Membership" button towards the bottom of the page. The link lets you complete an electronic form and connects to payment methods, e.g., PayPal or credit card. You can also print the form from the webpage, complete the form and mail it to: SRS Retiree Association, Inc. P. O. Box 5686, Aiken, SC 29804

### SRSRA Retiree Resource Center

Thank you to our retiree volunteers who have made our Retiree Resource Center (RRC) so successful. In the past 15 months, we have served over 1,000 clients. We've conducted 283 office visits and fielded 1,145 telephone calls. Between our work filing HE/WW claims (\$725,611) and our Medicare Rx Review program savings (\$299,411), our retirees' savings total \$1,025,022.

**Estate Planning.** We see many more retirees paying attention to planning. If you need help, we can work with you to update your primary and secondary beneficiaries for Prudential Life Insurance policies and Transamerica 401k plans. We can also help retirees add designated family members to these plans, their Medicare account, and to HealthEquity. Designees can speak to those agencies on your behalf. We can do this online and provide paper copies to keep for your records.

#### Retiree Health Reimbursement Accounts (HRA) with HealthEquity and VIA – Be aware!

These accounts are *notional* accounts which the webpage The Open Knowledge Repository (https://openknowledge.worldbank.org/entities/publication/546aaa2d-7461-5bd3-82b4-548cbabf5199, March 31, 2025) describes as "Notional accounts are designed to mimic a defined contribution plan, where ...the return that contributions earn is a notional one, set by the government, not the product of investment returns in the markets." These accounts are intended to qualify as a medical expense reimbursement plan and must meet IRS requirements so that the reimbursement benefits paid to eligible retirees and spouses are not taxable. Unlike a Health Savings Account (HSA), or your bank account, the amount shown as your HRA account balance does not belong to you and is not a "savings account".

Following your death there is a six-month window for HRA claims to be filed on your behalf. After that, any remaining balance is forfeited and reverts to the company of issue. If you are married and your surviving spouse is under 65 at the time of your death, a new HRA account will not be established until the surviving spouse reaches age 65, provided he/she meets the eligibility requirements.

If you are married and your spouse has been eligible for, and receiving allocations into the HRA, all remaining HRA funds remain in the HRA account and the annual stipend allocation continues for the surviving spouse until his/her death. Upon the surviving spouse's death, the same six-month window is open for filing claims on their behalf. After that any remaining balance reverts back to the company of issue.

The HRA is a retiree benefit. It is your responsibility to manage it wisely. The RRC has filed over \$5 million in retirees' HRA claims with HealthEquity/WageWorks, and VIA since 2014. We can assist you in getting reimbursements.

**Pay attention to your Rx drug expenses.** If you purchase your drugs outside of the Medical Part D Plan in which you are enrolled (e.g., from Good Rx, Publix, etc.,) you may find cheaper costs for that medication. You should know that that cost will not be considered when Medicare calculates catastrophic drug limit for 2025 and that will extend the time required to meet the \$2000 threshold Medicare defines for free medications.
